We ate Death Valley Rose brownies and sub sandwiches for breakfast and drew for prizes anyway. When Defend the Roost had run its course, several club members wanted to continue the second match every month, which we did on the condition that there were people who would write the stages and run the matches. Today we shoot cowboy matches twice a month, as often as not.


Even though our attendance per match is about a third of what it once was, with the addition of BAMB, Cowboy Three Rifle, and Trail Walks, the club's monthly income is often more than it was back when SASS was the self-proclaimed "fastest-growing shooting sport in the world." There was a time when the RRV had three times as many members as it has today. Considering that, we're doing fine.

The future of SASS is a question mark. The Wild Bunch has retired and put SASS in the capable hands of Misty Moonshine, and the SASS Wire is home to much speculation as to what will become of Founder's Ranch, who owns it, who owns SASS, etc. End of Trail is moving from Founder's Ranch in New Mexico to Phoenix, and the National Championship is moving from Phoenix to Oklahoma City, and what next? Who knows? The RRV continues to support SASS as an affiliated club, and I think all of us should continue as SASS members. But if SASS were to fold tomorrow, the RRV would still be here.

We have ongoing expenses like steel, paint, web site costs, water, dump station fees, misc. repairs, etc. And as of 12-16-2020 we have \$6926.40 in the bank.

Our membership application is here [RRV Membership Application](#) Annual membership dues for the RRV are: single membership \$25, member and spouse \$30, family membership (including children under 18 living at home) \$35. First time shooters will be able to take their FIRST (1) NEW SHOOTERS CLASS for \$10, any subsequent new shooters class or RRV match shoot will be \$10 members, \$15 nonmembers. Donations for shooting regular monthly RRV matches will be \$10 members, \$15 non-members. Memberships run from September 1 - August 31.
