### “¿Quién es?”

Every Old West aficionado recognizes those words. It's Spanish for “Who is it?” and they are the last words ever spoken by Billy the Kid—or are they?

The widely accepted story of the Kid's last night on earth is well-known. On July 14, 1881, Lincoln County Sheriff Pat Garrett and two of his deputies had gone to Ft. Sumner, New Mexico Territory, on a tip that the Kid was hiding there. The Kid was a fugitive from justice, having escaped from jail a few days before he was scheduled to hang for murder. In his escape he compounded his felonies by killing two of Sheriff Garrett's other deputies.

Around midnight, Garrett entered the bedroom of an acquaintance named Pete Maxwell. He sat on the edge of the bed and had just begun a conversation with Maxwell concerning the whereabouts of Billy the Kid when the door opened and a shadowy figure stepped into the room and asked that fatal question. Though he couldn't see him clearly, Garrett recognized the Kid's voice, raised his Colt Frontier Six-Shooter and fired two shots, one of which found its mark, and Billy the Kid was dead.

Well, maybe. Maybe even probably. But it gets kind of weird at this point. The first words out of the mouth of one of Garret's deputies upon getting a look at the body were, “That's not Billy.” Numerous acquaintances claimed they saw him in the days immediately following the shooting, and after Garrett's death his own daughter said he didn't kill the Kid. But, lots of people did identify the corpse as the Kid, and Garrett eventually got the reward money.

Did Garrett shoot the wrong man, and did the Kid's friends in Ft. Sumner keep the secret to protect Billy? “¿Quién sabe?”

## Range Security

We moved to our wonderful home on the RGRA range about ten years ago. Since that time, we have had occasional incidents where non-RRV members have trespassed on our range. A few years ago there was a break-in. They cut the locks on the sea vans and rummaged around, but nothing was taken. I guess the local meth-heads thought we stored guns out there, or something. Sierra Desert Gun Club was also hit at that time. Not too long ago the archery club's ATV was stolen, but was recovered.

What typically happens to us is people shoot holes in our steel with high velocity rifles firing jacketed bullets. It happened again very recently. It isn't done out of ignorance. We will also block the north/south road at the berm that separates our range from the police range. Here's hoping that will put an end to it.

### LOOKING BACK (and forward) AT BAMM AND SIDE MATCH DAY

Both of these events were a lot of fun, but sparsely attended. I believe they would draw more shooters if we did them again. That is based partly on wishful thinking, I admit, but also on declarations from lots of people that they wanted to attend one or both and for some reason couldn't.

Side Match Day was the more labor intensive of the two, requiring 11 venues to be set up for a total of 17 separate events. I would think long and hard about doing that again unless I was sure we would get more shooters. The bolt action match was easier; it was 6 stages on 3 sets like we do for a monthly match. I'd do that one again for the same handful of shooters.

So, another Bamm shoot is highly likely. Another Side Match Day is going to need some member input, including some thoughts on when would be a good time to do it.
